Important Questions	Answers	Why This Matters:
What is the overall deductible ?	\$2,000/individual contract or \$4,000/family contract for in-network services. \$4,000/individual contract or \$8,000/family contract for out-of-network services.	Generally you must pay all the costs from providers up to the deductible amount before this plan begins to pay. If you elect individual coverage, you must meet the individual coverage deductible amount. If you have family coverage, family members must meet their own individual minimum annual deductible of \$2,700 as defined by the IRS guidelines until the family deductible has been met.
Are there services covered before you meet your deductible ?	Yes. Preventive care is covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	For in-network providers \$6,750/person or / \$13,500/family. For out-of-network providers \$6,750/person or / \$13,500/family.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met .
What is not included in the out-of-pocket limit ?	Premiums, balance-billed charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
